The following steps are prescribed by Illinois law to collect past due taxes:

1. Mailing of a certified bill and the charging of a \$10.00 advertising fee.
2. The owners name, address, parcel number, and amount owed will be published in the newspaper. **Deadline for payment to avoid newspaper publication is October 07, 2025.**
3. A court hearing on an application of judgement against parcels with unpaid amounts will be held at 8:30 am on **November 06, 2025. Owner attendance is not recommended or required.**
4. A court ordered **TAX SALE** will be held at **10:00 am on November 07, 2025** to allow a tax buyer to pay the amounts due plus fees adding additional liability against the property which could result in loss of property.

# IMPORTANT INFORMATION ABOUT YOUR PAST DUE TAX BILL

## GENERAL INFORMATION

This bill is for current and prior year(s) taxes which are unpaid.  
Unpaid balances are subject to a 1.5% per month late penalty.  
Please check the late payment table to determine the proper amount to pay based on the date.  
Failure to receive your bill, or receiving it late, does not relieve the taxpayer of late penalty.  
Tax bills are available online under the Report/Forms tab at [tax.sangamonil.gov](http://tax.sangamonil.gov).  
Payments will be deposited when received and third-party checks are not accepted.  
A \$25 charge will be assessed for all insufficient funds transactions.  
Insufficient funds transactions will be referred to the States Attorney's Office for collection.

## **'EASY-PAYMENT' OPTIONS AVAILABLE UNTIL 5:00 PM ON NOVEMBER 6th 2024**

**TYPES OF PAYMENTS ACCEPTED** E-check, Cash, Check, Credit Card, and Debit Card.

**Please make checks payable to TAX COLLECTOR and include your parcel number on the check.**

**INTERNET** go to [tax.sangamonil.gov](http://tax.sangamonil.gov) to pay by **E-Check**. Use the search function to find your property. Click on the pay now button to pick the parcel you want to pay and then follow the prompts. E-check requires a bank routing number and an account number for either a checking or savings account. There is no fee for this service.

**MAIL** payments to PO Box 19400, Springfield IL 62794-9400 with payment stub. Retain the top of the bill for your records.

**DRIVE-THRU AND LOBBY** payments at any INB location with the stub (payment receipts are issued at INB).

**IN PERSON** payments at the Sangamon County Complex, 200 S. 9th St., Springfield, Illinois, Monday through Friday from 8:30am - 5:00pm until November 7th 2024.

**CREDIT & DEBIT CARD PAYMENTS IN PERSON, BY PHONE & THE INTERNET** are accepted with a convenience fee. Go to [sangamonil.gov/treasurer](http://sangamonil.gov/treasurer) and follow the prompts to make a payment online. Call **1-888-834-3729** to make a payment over the phone. A convenience fee will be charged based on the amount of your payment. The county receives no portion of this fee. Contact the Treasurer's Office for information on cards accepted and fees.

## **WHAT HAPPENS IF YOU DO NOT PAY**

Past due taxes will be sold at a Tax Sale if not paid prior to the deadline listed on the bill.

The tax sale process and collection procedures are governed by State of Illinois law.

State of Illinois law does not allow for payment plans to pay past due taxes.

The sale of the taxes will greatly increase the amount owed. In addition, the property owner could lose their property if the amounts are not paid within the "redemption period".

At the tax sale, a "tax buyer" will pay the taxes, tax sale fees, and interest on the unpaid tax to the County Treasurer.

The tax buyer will receive a tax sale certificate giving the tax buyer the right to charge you up to 9% interest added every 6 months on the sale amount.

The tax buyer also has the right to pay subsequent year's taxes, fees and interest and add it to the amount owed.

The tax buyer will charge 12% interest added every 12 months on the subsequent amounts.

Failure to pay all amounts owed can result in the tax buyer applying to the courts to take a tax deed to the property.

After receiving a tax deed to the property, the tax buyer may evict anyone occupying the property through the eviction process.
